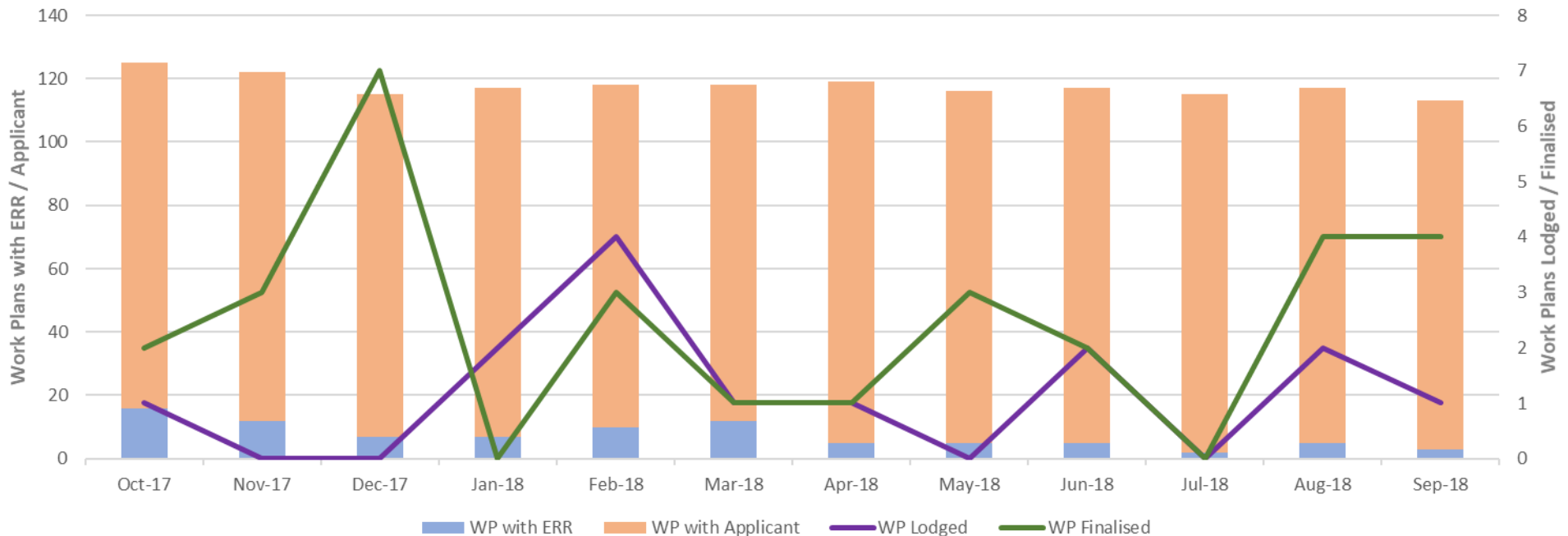

**Median Days #:** Arranging the stage duration in order and then selecting the one in the middle duration. Median is used to minimise the impact of outliers.

**No. Work Plans\*:** The number of work plans that had that stage assessed in the year. A single Work Plan may have had a stage assessed multiple times.
