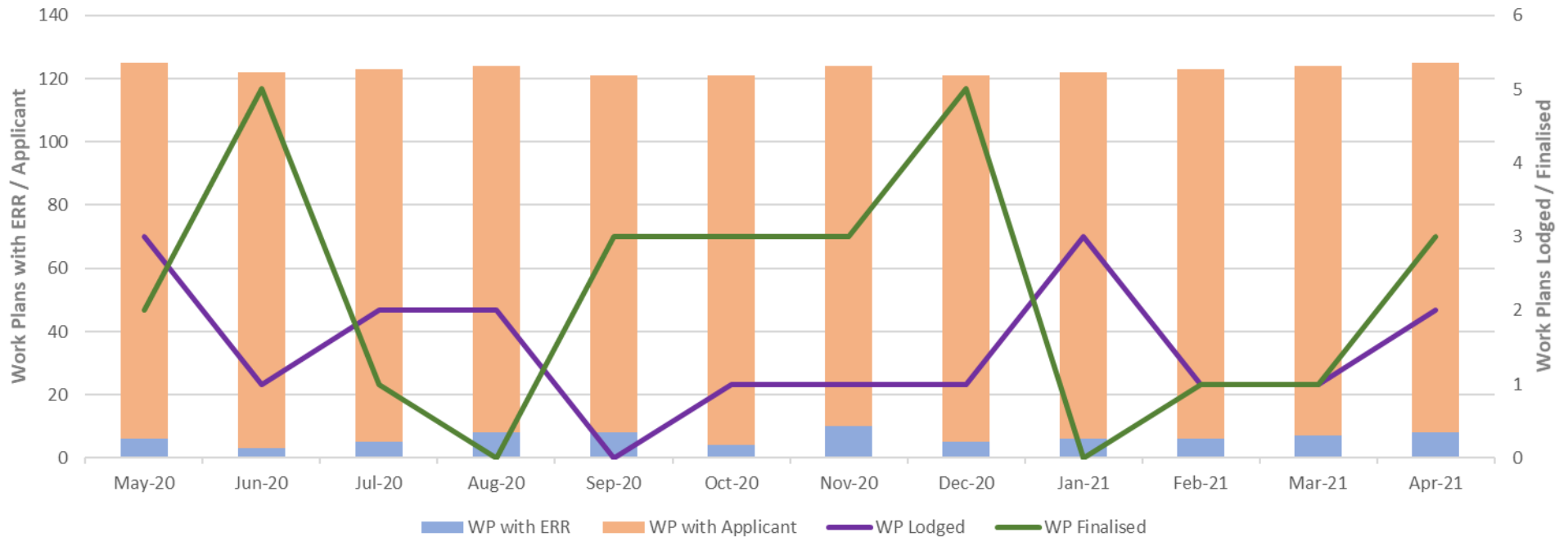

No. Work Plans*: The number of work plans that had that stage assessed in the year. A single Work Plan in a month can have had a stage assessed multiple times.
