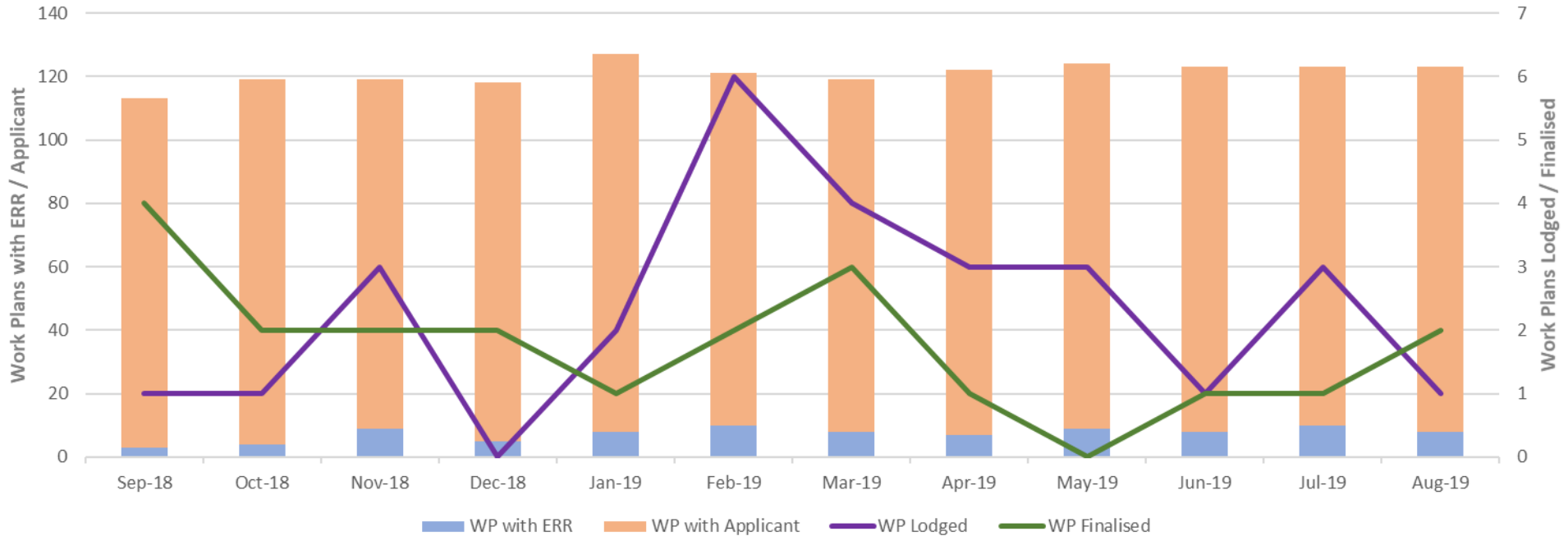

**No. Work Plans\*:** The number of work plans that had that stage assessed in the year. A single Work Plan Sept have had a stage assessed multiple times.
