Legend **A** – Approved **R** - Refused **W** - Withdrawn

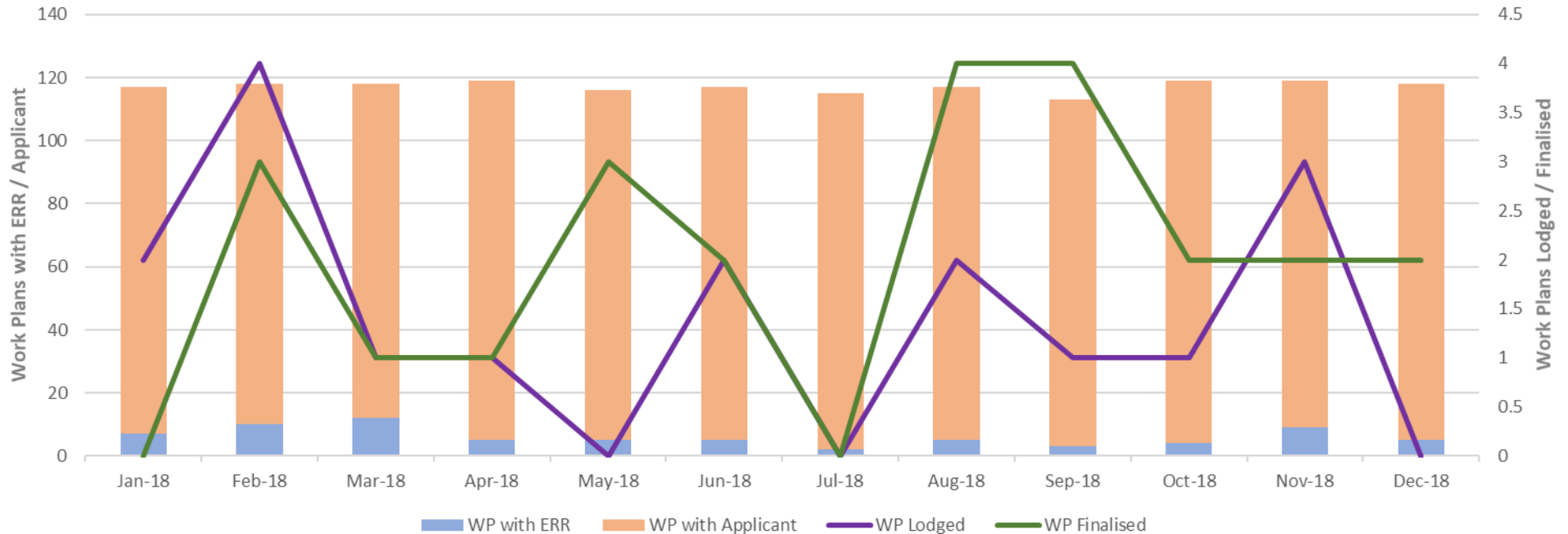
